Basic Rules - PLEASE READ THOROUGHLY

1. **Check-in begins at 8:15am, Paddock at 8:50am, and bowling starts at approximately 9:00am. Walk in entries will NOT be accepted. Players not checked in by 8:45am may/will forfeit their spot.**
2. All participants must be USBC sanctioned and MJBT members in good standing (no unpaid memberships, fines, etc)
3. All competition is scratch. Handicap will not be given to any player/team.
4. Separate women's division if 7 or more female teams are entered. Otherwise, all will compete in one division.
5. Team pairings with CBA players will be completed via random draw at the tournament site.
6. All teams bowl 12 baker style games across 24 lanes. Players will alternate start/finish order for each game. The top male and female teams go to head-to-head stepladder finals. Stepladder matches will be 2 game baker style matches. MJBT player will always complete the game during the stepladder finals.
7. Scholarships paid out for high qualifier and high game out, along with top finishers. Plaques also awarded to champions (youth and adult). All award fees returned 100%.
8. No denim, caps or hats allowed. All bowlers must wear collared shirt with name on back and MJBT logo attached. Dress shorts/skirts of appropriate length are acceptable for women. Dress shorts/slacks acceptable for male bowlers.
9. All MJBT rules regarding player conduct will be enforced during this event. Fines may/will be given, if needed.
10. Entry fees are as follows: Prize fund \$50; Lineage \$0, Directors Fees \$0 = \$50 total
Late Entry: add \$10 to above fees.
11. Optional bracket competition will be offered. Cost is \$5 per bracket, with no limit on amount of brackets entered. There will be 4 sets of brackets (Games 1-3, 4-6, 7-9, and 10-12).
12. Entries not received on/by deadline date, subject to \$10 late charge and spot will not be guaranteed. Entries should be sent at least 10 days prior to the deadline to help ensure timely delivery.
13. Failure to show for event without approved cancellation will result in loss of all entry fees. Cancellations should be minimum 48 hours in advance of event. All others subject to discretion of Tournament Management.
14. Entry confirmations will only be posted online, and not sent out to individuals. To confirm, visit our website at www.mjbt.org. In the event entries exceed posted limits, a waiting list will be implemented.
